Regarding the Board of Trustees: There are 8 potential positions. Anyone wishing to stand for election to the Board of Trustees should complete the relevant Nomination Form and ensure it is returned to Anna Garland or placed in the Trustee pigeonhole by 5pm on Friday 26th September 2025

Mike Baker was co-opted to the Trustee Board of SP on 19th November 2024. He is willing to stand for election

The SP Constitution requires one third of the Trustee Board to stand down each year on a rolling basis. Martin Parr and Will Lidbetter, as the longest serving Trustees across SPADS and SP, are standing down. They are both willing to stand for re-election

Regarding members of Sinodun Players Committee (SPC): There are 6 vacancies. Anyone wishing to stand for election to SPC should complete the relevant Nomination Form and ensure it is returned to Anna Garland or placed in the Trustee pigeonhole by 5pm on Friday 26th September 2025

Caroline Malnick, Dorothy Hirsch, Anne Stammers and Julie Utley are willing to stand for reelection

Regarding SPC Chair: The position of SPC Chair is voted in by the membership. The position of SPC Chair will be vacant because Caroline Malnick is standing down from the SPC (but is willing to stand for re-election).

If Caroline Malnick is re-elected to SPC she is willing to act as Chair, subject to the vote of the membership. However, she has indicated that she would not stand as Chair if another SPC member was willing to stand.
